REQUIRED DOCUMENTS – COMPULSORY

Thank you for submitting the required documents by May 8th 2017 at the latest:

- A copy of the lawyer's card (the original will be requested to be shown on arrival in Maribor), for each player,
- A medical certificate of less than one year authorizing to play competitive football under the conditions of **EUROLAWYERS** (4 to 6, 60-minutes matches in 5 days), for each player,
- 1 passport color photograph, for each player and its guests,
- 1 player sheet dully filled in and signed, for each player.

EXEMPTIONS

⇒ **For the EUROLAWYERS, to build your team we may accept:**

- **11-a-side, Classic Tournament:**
 - TWO exemptions per team for non-lawyer player,
 - Each exempted-player must be over 30 and a member of the legal community,
 - Players playing or who have played in football clubs at professional or semiprofessional level are not accepted.
- **11-a-side, Master Tournament:**
 - TWO exemptions per team for non-lawyer player,
 - Each exempted-player must be over 35 and a member of the legal community,
 - Players playing or who have played in football clubs at professional or semiprofessional level are not accepted.
- **5-a-side, Classic Tournament:**
 - ONE exemptions per team for non-lawyer player,
 - This exempted-player must be over 30 and a member of the legal community,
 - Players playing or who have played in football clubs at professional or semiprofessional level are not accepted.

These conditions are mandatory but not sufficient to guarantee an exemption.

For any demand of exemption, you must send, during the registration and by May 8th 2017 at the latest, the required documents:

- An individual certificate of membership of the profession justifying their activity,
- A sworn declaration signed by the captain of the team certifying that the player asking for an exemption is not and has never been player in football clubs at any level,
- A medical certificate of less than 1 year,
- 1 passport color photograph.

ACCOMMODATION AND STAY PACKAGE - PAYMENTS

IMPORTANT: No reservation will be confirmed without a deposit. Any reservation previously made and not fully paid by the due date – given in the schedule of payments – will be considered as a cancellation of participation. CSO will, in that case, reserve the right to dispose of the rooms previously reserved. **Any cancellation may lead to penalties (page 8, conditions of sales).**

2 – Cancellation conditions

The conditions for cancellation are those listed in this registration form, here below.

2.1 – Cancellation of tournament registration and accommodation fees

<i>Cancellation received before February 7th, 2017:</i>	<i>No withholding</i>
<i>Cancellation received between February 7th, 2017 and April 7th, 2017:</i>	<i>Withholding of 50% of deposit already paid for registering in the tournament</i>

These cancellation fees also apply to any reduction in the number of persons initially registered with your delegation and accommodation reservation. The number of persons making up your delegation and their allocation in rooms should be communicated to the organizers before April 8th, 2017.

2.2 – Cancellation of the event

Should, for reasons of absolute necessity (war, attacks, strikes, riots, bad weather, natural disaster, epidemics...) the tournament be cancelled, CSO will not refund the registered teams the sums already paid, for the registration and the journey.

In that case, CSO would do its utmost to have these sums held toward a rescheduled EUROLAWYERS tournament in Maribor at some later date.

If, for reasons beyond the control of CSO, the tournament is definitely cancelled, the teams already registered will have to be responsible on a pro rata scale for the amounts committed to by the CSO, over and above the amounts already transferred to Maribor.

3 – Conditions of sales

The specific conditions of sale listed here refer to the current provisions of the French law, and more specifically to those of articles 95 and 103 of decree 94490 dated June 15th, 1994, which constitute our conditions of sale.
